<b>What is the overall <a href="#">deductible</a>?</b>	\$1,500/person or \$3,000/family for In- <a href="#">Network Providers</a> . \$3,000/person or \$6,000/family for Non- <a href="#">Network Providers</a> .	Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the <a href="#">plan</a> , each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family <a href="#">deductible</a> .
<b>Are there services covered before you meet your <a href="#">deductible</a>?</b>	Yes. <b>What is the <a href="#">out-of-pocket limit</a> for this <a href="#">plan</a>?</b>	\$4,000/person or \$8,000/family for In- <a href="#">Network Providers</a> . \$8,000/person or \$16,000/family for Non- <a href="#">Network Providers</a> . This <a href="#">plan</a> has a separate Out of Pocket Maximum of \$2,850/person or \$5,700/family for In- <a href="#">Network Providers</a> \$5,700/person or \$11,400/family for Non- <a href="#">Network Providers</a> for <a href="#">Prescription Drugs</a> .
